1.	The candidates of only Indian Nationality can apply for these posts.
2.	There is No Application Fee for applying to any post.
3.	The Candidates must carry the original photo id proof which has been mentioned in the application, at the time of interview for verification.
4.	The Board reserves the right to post the selected candidates anywhere in India other than the duty station mentioned above.

5.	Experience specified for the above posts shall be the experience acquired after obtaining the Essential Educational qualifications prescribed for the posts.
6.	Applicants are required to upload only scanned copy of Experience Certificate(s) in the field of Environmental Pollution management/control with the application form and no other certificates/supporting documents are required to be uploaded. However, the same will be produced at the time of interview.
7.	After submitting the application, applicants are advised to visit the CPCB Recruitment Portal frequently for any update on the status of his application.
8.	Applicants are advised to ensure before applying that they possess essential qualification and experience for the post. The Experience & Qualification will be reckoned as on the last date for submission of application. No updating of qualification and experience will be entertained after the last date.
9.	Application once submitted cannot be altered/resubmitted, under any circumstances. 12.	The character of a person for appointment must be such as to render him/her suitable in all respect for appointment to the post of Consultant.
